# HOSPITAL EMERGENCY PREPAREDNESS • Oct. 20 & 21, 2009

## OVERVIEW

This program is for all hospital emergency response personnel and community health agencies that may need to interact with hospitals during an emergency.

Emergency management plans are meant to be living documents — and good emergency management plans make good business sense. Whether a facility is accredited by The Joint Commission or not, many of the standards will likely become national standards. This program is designed to help demystify Joint Commission standards and assist participants in identifying and overcoming barriers to implementation of a successful emergency plan within their facility.

## SPEAKER

**Joseph Capiello, BSN, MA**, is chair of Capiello & Associates and the former vice president for accreditation field operations at The Joint Commission. He spent 10 years at The Joint Commission directing key internal functions, as well as serving as a surveyor. He led Joint Commission initiatives on emergency management and disaster response, personally debriefing nearly 300 healthcare organizations following disasters. He testified before Congress following his experiences with Hurricane Katrina and before the National Transportation Safety Board following the evacuation of Houston during Hurricane Rita. He is a frequently requested speaker on both the national and international stage and is a contributing author to several publications on emergency preparedness and response. Before joining The Joint Commission, Capiello served as a project manager for a national healthcare reengineering firm and as an executive director of a large academic medical center. He has more than 30 years of diverse experience in delivery system integration, operations reengineering, strategic planning, healthcare policy development, and emergency planning.

9. Understand how social media tools (twitter, facebook etc.) can be utilized to manage an emergency.
10. Identify the communication networks available to urban rural and frontier regions.
